Notification of Debarment

Golden Maritime Technology (GMT), HAK Tower (4th Floor), 3/C Kawran Bazar, Dhaka- 1215, Bangladesh in capacity of local agent of Jason Electronics (PTE) LTD, 194 Pandan Loop, # 06-05, Pantech Business Hub, Singapore 128383, participated Tender for “Procurement of Specialized ICT Equipment (VHF and HF Radio Terminals), Lot-2: HF, Package No.: URP-DNCC/G-1.1” on July 20, 2017 to Urban Resilience Project-DNCC Part.

During evaluation of tender, it was found that the bidder submitted an edited and manipulated documents for JITC (Joint Interoperability Test Command) reports for the Item, HF Fixed Radio, Model: MICOM-Z. The bidder submitted test reports with the bid documents that mentioned ELBIT C41 system. The country of origin for ELBIT C41 system is Israel. When the bidder was asked for clarification, then the bidder deleted ELBIT C41 from the reports and submitted. This is a fraudulent act according to PPR-2008, Rule 127 (2) (kha) and World Bank Policy – Corruption and fraudulent Practice, Para 1.16 (a) (ii). The bidder was asked explanation on October 30, 2017 why the Firm would not be debarred to participate tender in DNCC. The bidder replied through RHT Law Taylor Wessing and mentioned that his local agent submitted this paper and then the bidder withdrew the bids and cancelled the authorization of local agent GMT. The reply of the bidder proved the fraudulent allegation against Golden Maritime Technology.

Now the DNCC Authority declares debarred of “Golden Maritime Technology (GMT), HAK Tower (4th Floor), 3/C Kawran Bazar, Dhaka- 1215, Bangladesh” for the next two (2) year to participate any tender under URP-DNCC Part and Dhaka North City Corporation.


